Overview

Million Dollar Directory is a valuable source of information on both privately held and public companies. It also contains easy-to-use cross references, primary and secondary lines of business and the names and titles of company officers and directors.

Listing Criteria

Companies must meet at least one of two inclusion requirements:

- \$9,000,000 or more in sales volume
- 180 or more employees total if the company is a headquarters or single location; 900 or more employees at that location if the company is a branch.

Information for the *2007 Million Dollar Directory* was collected from the D&B Information Base. This information was obtained from the December 2006 extraction of D&B's Dun's Market Identifiers file.

Million Dollar Directory — Series

Million Dollar Directory Series is published in five volumes—the first three volumes contain alphabetical listings, while the fourth and fifth are cross-reference volumes grouped geographically by state and by Standard Industrial Classification (SIC).

Million Dollar Directory — Top 50,000

Million Dollar Directory Top 50,000 is a separate publication that includes the leading 50,000 businesses from the Million Dollar Directory Series. These listings are selected based on sales volume and number of employees.
